ITEM NO. 3 Consideration of Liquor License Renewal Applications for License Year 2011-12

Currently in the 2010-2011 license year, there are 57 active liquor licenses. All but two of the current license holders applied for renewal of their liquor licenses. The two license holders that did not apply for renewal are Melange (Class A2) and Hundley House (Class D).

Attached is a list of the licensed liquor establishments, grouped by classification of license, for which a liquor license renewal application has been submitted. Listed next to each individual establishment are the items (if any) that remain outstanding. This list is current as of June 16, 2011. However, required items are still being submitted by the license holders and Building and Neighborhood Services and the Fire Department are continuing their reinspections. As a result, an updated list will be provided at the Liquor Commission meeting. In order to save copying costs, copies of the individual renewal applications have not been provided to Commission members. However, the applications can be made available at the Liquor Commission meeting if any Commissioners would like to review them.

Ice Box Bar and Grill and The Premiere Lounge were both approved for a liquor license by the Commission on May 17, 2011. They both currently have a 180-Day Permit for License expiring on June 30, 2011. Should their license renewals be approved, a new 180-Day Permit for License will be issued for the 2011-2012 license year, and their licenses will be issued upon receipt of all outstanding items.

Liquor Advisory Board review: The Liquor Advisory Board reviewed the liquor license renewal applications at its June 2nd meeting and recommended approval of all requests contingent upon receipt of outstanding items.

Alternative Actions

The Commission may approve the renewal of the 57 liquor licenses as listed on the attached sheet pending receipt of all outstanding items, including new licenses for Ice Box Bar and Grill and The Premiere Lounge, also contingent upon receipt of all outstanding items.

OR

Should the Commission wish deny the renewal of any current liquor license or the licenses for Ice Box Bar and Grill and/or The Premiere Lounge, denial should be based on one or more of the provisions of Section 2-4-5 of the *Liquor Code* (printed on the reverse side of this Action sheet).
