5. Terms, Conditions, and Signatures: A copy of the approved permit must remain with the applicant throughout the event. All participants are to use the permitted access area only (boat ramp & parking); use of the other non-permitted access is prohibited for the above event. The Carbondale access is located on the northeast end of the lake at the west end of Cedar Creek Road; the Pomona Township access is located on the southwest arm of the lake at east end of Boat Dock Road.

I understand and agree to communicate to all participants of the fish-off/fishing tournament the regulations and rules concerning such events, which are available on line at www.explorecarbndale.com and posted at the Carbondale access to Cedar Lake. A concise, downloadable version of the rules is also available on the Cedar Lake page on the City's website or may be included with this application. All anglers are responsible for knowing and obeying the state fishing regulations for the lake which are published by Illinois Department of Natural Resources (IDNR) and are available on line at www.dnr.illinois.gov . Creel limits should also be posted at both access areas. Statewide tournament permits are required for organized competitive fishing events, as well. Other state of Illinois fishing and boating regulations also apply. Non compliance may result in fines and/or denial of future fish-off requests.

I also understand that once a permit is approved, the fee is non-refundable within thirty (30) days of the scheduled event.
